With this data protection declaration we, AXSYS GmbH, Schwammertstrasse 14, D-54589 Stadtkyll, inform you about all data protection aspects of the offer of salico.de as well as salico.biz website (the "Website").

We collect, process and use your personal data only in accordance with the following privacy policy. Personal data in this sense are all individual details about personal or factual circumstances of a specific or identifiable natural person, such. Your name, telephone number, address, and any other information you provide to us when registering, using our services or contacting you ("Personal Information").

I. Responsible for data processing

AXSYS GmbH is responsible for data processing within the meaning of Art. 4 No. 4 of EU Regulation 2016/679 ("DSGVO").

II. Collection and storage of personal data and the nature and purpose of their use

1. Processing of data for the use of the website

If you access the website via your browser or the app via your mobile device, we only collect personal data that your browser or mobile device automatically transmits to enable you to visit our website or app and the stability and to ensure safety. This can be especially:

- ♣ your IP address,
- ♣ your device identification, i. the unique number of the terminal,
- ♣ the content, date and time of the request,
- ♣ the time zone of the requesting computer or mobile terminal,
- ♣ the website from which the request was forwarded,
- ♣ the requested page,
- ♣ the http status code,
- ♣ the amount of data transferred,
- ♣ browser ID,
- ♣ your operating system,
- ♣ Language and version of the browser software

The processing of this data serves:

- ♣ ensuring a smooth connection of the website,
- ♣ the display of our services and products,
- ♣ the usability of our services,
- ♣ the evaluation and system security and stability as well
- ♣ for further administrative purposes.

The legal basis of this processing of your personal data is Article 6 (1) sentence 1 lit. f DSGVO. Our legitimate interest follows for the aforementioned purposes of data collection.

2. Processing of data when using a contact form

We do not offer you the opportunity to contact us via a form provided on the website.

3. Processing of data for the use of our services and products

If you wish to use our services and products, you may be asked at different times to provide us with personal information such as specify.

Your personal data will be processed and required by us for the following purposes:

- ♣ pursuant to Art. 6 para. 1 lit. b and lit. c DSGVO for contractual obligations and legal requirements: to send you important @Mails about the use of the website, the products and services offered, up-to-date information about technical problems or matters related to our legal or regulatory obligations; as
- ♣ in accordance with Art. 6 para. 1 sentence 1 lit. c DSGVO due to legal requirements or pursuant to Art. 6 para. 1 sentence 1 lit. e DSGVO in the public interest: to protect you and us (including our affiliates) from fraud and for identity verification purposes.

III. Disclosure of your data to processors and third parties

We do not intentionally use third parties or organizations to process your data.

Marketing automation solutions, web analytics tools, and IT service providers never get in touch with your data in any way. Your data will be carefully selected by us and will be checked regularly.

Incidentally, your personal data will only be forwarded to third parties (authorities) if you have previously submitted them in accordance with Art. 6 para. 1 sent. 1 lit. a DSGVO have consented or a legal permission i.S.d. Art. 6 para. 1 sentence 1 lit. c DSGVO or a court order.

The legal basis for the processing of your data for the purpose of sending newsletters is Art. 6 para. 1 sentence 1 lit. a or lit. f DSGVO.

We deliberately never use third parties, organizations or companies to send our @Mails and Newsletter.

VIII. Duration of storage

We store your personal data as long as this is necessary to achieve the respective storage purpose. Subsequently, your data will be deleted by us, unless, according to Art. 6 para. 1 p. 1 lit. c DSGVO are obliged to retain for a longer period of time due to tax, commercial or other statutory storage or documentation obligations or you are obliged to make further storage in accordance with Art. 6 para. 1 sentence 1 lit. a DSGVO have agreed.

IX. Your rights

In accordance with Art. 15 GDPR, you are entitled to provide information about your personal data stored with us at any time. In particular, you may provide information about the purposes of processing, the categories of data you have stored, the categories of recipients of such data, the planned duration of storage, the right to rectification, cancellation, limitation of processing or opposition, the existence of a right of appeal to a regulatory authority, the origin of your data, if they were not collected from you, as well as the existence of an automated decision-making process including profiling and, if necessary, meaningful information about their details.

In addition, according to Art. 16 GDPR, you may request the correction of incorrect data and, pursuant to Art. 17 GDPR, the deletion of personal data, as far as the processing of the exercise of the right to freedom of expression and information, to fulfill a legal obligation, for

reasons of public interest or to assert, exercise or defend legal claims.

Furthermore, you have the right to demand, pursuant to Art. 18 GDPR, blocking or restriction of the processing of your personal data if the accuracy of the data is disputed by you, the processing is unlawful, but you reject its deletion and we no longer need the data, However, you require them to assert, exercise or defend legal claims or you have objected to the processing in accordance with Art. 21 GDPR.

Furthermore, according to Art. 20 GDPR, you have the right to receive your personal data that you have provided to us in a structured, common and machine-readable format or to request the transfer to another person responsible.

If your personal data are based on legitimate interests pursuant to Art. 6 para. 1 sentence 1 lit. f DSGVO, you have the right to object to the processing of your personal data at any time in accordance with Art. 21 GDPR, as far as there are reasons for this arising from your particular situation or the opposition against processing for the purposes of Advertising directed. In the latter case, you have a fundamental right of objection, which is implemented by AXSYS GmbH without stating a particular situation.

If you believe that the processing of your personal data by us is not in accordance with applicable law, you may file a complaint with a supervisory authority pursuant to Art. 77 GDPR.
